Collection– The Buyer will be required to bale, load and carry away the straw at this own expense once the item/s are paid for in full and to leave the fields clear of broken bales.

Description – To be written as it will appear online. Rostons will not be responsible for any misdescription.

Ownership - All straw sold must be in the sole ownership of the party listed as the trading title at the top of this form.

COMMISSION - Standing Straw is 5%.

Payment - We aim to pay out within 7-10 days following payment received from the purchaser.

Terms & Conditions of Rostons Online Standing Straw Sale

Vendors

1. The vendor to accurately complete this entry form for each lot taking care to describe the acreage and quality for cataloguing. The vendor to provide a photograph for each lot.
2. The Seller will notify each buyer when the straw which he has purchased has been combined.
3. The vendor is to allow potential purchasers to inspect lots at any mutually convenient time.
4. A reserve price may be put on each lot if required.
5. Upon failure to comply with the clearance date the purchase money will be forfeited and the Seller will be free to dispose of the straw in any manner to suit himself without compensation to the Buyer.

Purchasers

1. The purchaser to bid online for the lots based on the description in the catalogue provided by the vendor.
2. Pre inspection of lots permitted by contacting the auctioneers for the vendors details.
3. The purchaser has 7 DAYS from the sale day to register any complaints about description or quality to the auctioneers. NO CLAIM PERMITTED after this time.
4. The buyer cannot remove any Standing Straw until cleared payment has been received in full.
5. Payment of lots to be made by debit card or BACS within a week of the sale to Rostons.
6. Collection of each lot is the sole responsibility of the purchaser who shall indemnify the vendor if any damage caused to his property during removal.
